### 12. Feedback from Elders Observers

- Helen Starr brought up concerns regarding guidance for older students to assist in their careers. Chief Billy Joe
  responded that KTCEA was to ensure that students would succeed; Gwena Cunningham does excellent work but
  has a lot of ground to cover. We need to enhance and build academics to excel in higher courses.
- Gordon Shaw indicated that we are at a good time to target the future, which is the children. He agreed with
  Helen Starr. Councillor Tyler Letendre responded that we are on the right track, and we need to continue to boost
  parents' involvement at home.
- Ruby Letendre says that sometimes the desire to go further disappears in children after they graduate. We have
  to make sure they are making the right choices. Councillor Frank Whitehead responded that we are on the right
  track and that we need to make sure that we continue giving children all the best chance. We need less turnover
  in school leadership and to teach the language.
- Councillor George Merrier is concerned that there is bullying in the school and that there needs to be more control
  over the children. We need some type of security monitoring in the school as there have been people doing drugs
  within the school and grounds. We need to improve the chances that our students get to upgrade their courses.
- Larry Ominayak says that we need more staff in the schools. There needs to be protocol to be able to give feedback to KTCEA, even if people are scared to speak up How many EAs can a school have, especially for Cree?
- Chief Ivan Sawan responds that the Board is there to bring information to the community, and that their hearts
  and passion are in giving the best chance to children at the school. KTCEA is staffed with 67% First Nations
  people, 39% from KTC First Nations. We are opening doors with MES and ATEP.
- Richard Laboucan stressed the need for security. There had been two lockdowns. Students are taking drugs in the school, and that had been lessened with security.
- Chief Ivan Sawan recommends that this may be used in other schools. Pearl to follow up.
